### **COURT & LEGAL FEES**

<b>Court Appearance Retainer</b>	<b>\$1,500/half day (4 hours)</b> <b>\$3,000/full day</b>
<b>Preparation Time</b>	<b>\$300/hour (billable in 15 min increments)</b>
<b>Phone Contacts</b>	<b>\$300/hour (billable in 15 min increments)</b>
<b>Depositions</b>	<b>\$500/hour</b>
<b>Time Required in Giving Testimony</b>	<b>\$500/hour</b>
<b>Mileage</b>	<b>\$0.65/mile (IRS business mileage rate)</b>
<b>Time Away from Office Due to Deposition or Testimony</b>	<b>\$300/hour</b>
<b>If Court Case is Located Outside of 50-mile Radius of Therapist's Office</b>	<b>lodging/hotel fee (if applicable)</b>
<b>Filing a Document/Form with the Court</b>	<b>\$100 per document/form</b>
<b>Attorney Costs Incurred by Therapist as a Result of Legal Action</b>	<b>varies</b>
